Dear Mr. President,

As the Trustee for the State of Louisiana under the Oil Pollution Act of 1990 (OPA 1990), and pursuant to 33 U.S.C. §2706(b)(3), I am required to notify you of any designees authorized to act on behalf of the State of Louisiana as Trustees for natural resources of the State. Consistent with this duty, the purpose of this letter is to update the designations for three of the State Natural Resource Trustees as follows:


